**Financial Report**

Windy Standard, Wetherhill and the administrative accounts have been amalgamated into one account. £50,000 has been transferred to a high interest account that will mature in January 2013.

Current balance stands at £57,237.76.

Francis Scott is arranging online banking.

**SPRUK discussions and Weatherhill agreement**

Francis and Tom Scott, Margaret Richmond, Anne Rutherford and the solicitors have met to discuss the new “Minute of agreement” between Scottish Renewables (UK) Ltd and CREFL. On Page 4 Section 4.1 of the agreement, it claims that the pre commissioning payment of £10,397 has been made to CREFL. This money has not been received by CREFL. The money from this fund had initially been held with Hewats but their records show that no pre commissioning payment was made. The 1st payment received was for Weatherhill power output. It was agreed that the “Minute of agreement” should not be signed until further investigation has been made. Stephen Lindsay from SPRUK is looking into it and will report back to CREFL.

There were further concerns about page 6 section 4.8 where the condition to “*discuss with SPRUK in advance how the payments referred to in this Agreement are to be allocated*” appear to have been added. It was agreed that this needed to be reworded.

**Grant Application Forms**

The proposed change to the wording of the Further Education Great Application to “*A grant of £250 may be awarded once in any 12 month period during your course*” was agreed. It was also agreed that the application would be available on the Carsphairn website.

## **Community Benefits**

In the D&G Council Community Benefits Booklet, the council proposes that there is a 50/50 split of any funds available through wind farms. There is a claim that communities can opt out of this scheme but this has not yet been confirmed by the council. George Prentice has given reassurance that this is the case and that CREFL are “doing the right thing”.

## **Correspondence**

The proposal for the Longburn wind farm and the Newsletter for the South Kyle wind farms were circulated. A request from npower renewables to sign up to their Register of Community Benefits from Renewables was agreed. Francis Scott will register with them. A letter was submitted from the secretary of the Hall Committee flagging the possibility that they may, if other funding is unavailable, be applying for a grant in the future towards the costs of building an extension.
